Subject :- Deployment of staff for the verification of scanned files.

Sir,

I am directed to refer to the subject cited above and to say that the process of digitization of Record Rooms in the State under the Modern Record Room Component of DILRMP has been started but due to slow progress of verification of scanned record is too slow due to which the deployment of sufficient scanning staff has also been slowed down by the vender. In order to verify scanning files at the 06 Scanning Locations setup in the State under the Record Room Digitization Project, there is urgent requirement for appointment of 26 Data Entry Operators on outsource basis at scanning location. However, in view of the orders of the Hon'ble High Court dated 07.11.2024 in CWP No. 7474/2022, the Director, Land Records is not in a position to appoint the personnel on outsource basis immediately.

As the process of verification of scanned records cannot be started till the availability of required personnel, it is therefore requested to spare the clerical staff well versed in Computer application/data entry from the office(s) under your control for their further deployment in following 06 Scanning Locations as a stop gap arrangement till manpower on outsources basis is made available :-




