Availability of works list having financial as well as technical sanctions ready-regarding

Sir/Madam,

I am directed to enclose herewith a copy of DO letter No. J-11060/41/2021/RE-VI (377529) dated 26th June, 2023, received from the Ministry of Rural Development, Govt. of India. wherein it has been intimated that as per the provision of para-14 of Schedule I of the Mahatma Gandhi NREG Act, 2005, the works finalized at the Gram Panchayat level and consolidated at the Block or District level shall be given Block-wise administrative or financial sanction by the competent authority within thirty days from the date of finalization of the works at the Gram Panchayat level, only after confirming that the shelf of works in any Gram Panchayat is not less than two times the labour budgets approved for that Gram Panchayat. There is no restriction to accord administrative and financial sanction of the technical estimates in advance, once the shelf of works is prepared.

You, are, therefore requested to ensure that the administrative and financial sanction of at least 50 % of the works available in the 'shelf of works' may be kept ready all the time during any financial year to ensure that work is provided to the workers on demand without any delay.

Madam/Sir,

As you are aware that as per the provisions of para-14 of Schedule I of the Mahatma Gandhi NREG Act, 2005, the works finalized at the Gram Panchayat level and consolidated at the Block or District level shall be given Block-wise administrative or financial sanction by the competent authority within thirty days from the date of finalization of the works at the Gram Panchayat level, only after confirming that the shelf of works in any Gram Panchayat is not less than two times the labour budget approved for that Gram Panchayat.

2. However, there is no restriction to accord administrative and financial sanction of the technical estimates in advance, once the shelf of works is prepared.

3. In view of the above, the States/UTs are requested to ensure that the administrative and financial sanction of at least 50% of the works available in 'shelf of works' may be kept ready all the time during any financial year to ensure that work is provided to the workers on demand without any delay.
