Subject: Regarding proper deduction of GST and check on M-form-Instructions thereof.

Sir,

I am directed to invite your attention on the subject captioned above and to say that the State Government has observed certain lapses in GST compliance and the verification of M-Forms under the schemes being implemented by this department, these lapses compromise financial transparency, disrupt compliance, and affect the efficiency of schemes. Additionally, the M-Form is essential for verifying the legitimate movement of mining materials, ensuring tax compliance, preventing unauthorized transactions, and validating the source and quantity of supplies.

2. As such, after careful examination, it has been decided that now the vendors are required to submit an affidavit before commencing supplies, affirming adherence to departmental guidelines, including timely delivery, submission of M-Forms with bills, and accountability for any discrepancies. Payments will not be processed unless these conditions are met. Format of the affidavit is enclosed.

3. Additionally, the details of the M-Form submitted by the vendor can also be check on the official portal at <https://emerginghimachal.hp.gov.in/miningstone/official/Reports/mFormDetails>.

4. The following additional responsibilities have been assigned to field functionaries to ensure compliance:

- (i) **Panchayat Secretaries** shall approve bills only if they are submitted by GST-registered vendors and contain the HSN code, GST slab rate, and GST amount for schemes such as MGNREGA, Planning, RGSA, 15th Finance Commission, State Finance Commission, Swatch Bharat Mission, or any other scheme implemented by the Rural Development & Panchayati Raj department. Additionally, for bills related to mining materials, they must ensure that the M-Form is attached.
- (ii) **Technical Assistants (TAs)** are required to verify the quantities

specified on bills against those recorded in the M-Form for schemes such as MGNREGA, Planning, RGSA, 15th Finance Commission, State Finance Commission, Swatch Bharat Mission, or any other scheme implemented by the Rural Development & Panchayati Raj department.

(iii) **Gram Rojgar Sahayaks (GRSs)** are responsible for uploading only those bills that meet all compliance requirements and are duly approved in case of MGNREGA.

5. Furthermore, **Panchayat Secretaries** are required to submit a scheme-wise monthly report to the Block Development Officer (BDO), detailing the materials booked and the corresponding GST collected as MGNREGA, Planning, RGSA, 15th Finance Commission, State Finance Commission, Swatch Bharat Mission, or any other scheme implemented by the Rural Development & Panchayati Raj department.

6. Additionally, the Block Development Officer (BDO) must forward these reports to the State Excise and Taxation Department, Himachal Pradesh, to verify and monitor GST collection to ensure compliance and prevent revenue leakage.

7. It is therefore requested to convey the above decision of the State Government to the field functionaries for strict adherence with immediate effect and the failure to comply with these guidelines will lead to appropriate actions as per the rule.
