I am to inform you that a meeting regarding establishment of 500 new Herbal Gardens was held on 23.05.2023 under the Chairmanship of Worthy Secretary (RD & PR). Besides the Officer of RD & PR department, this meeting was also attended by the Officers of AYUSH & Horticulture department.

The main agenda discussed in the meeting was regarding implementation of Budget Assurance relating to establishment of 500 new Herbal Gardens. After detailed discussion, the following decisions were taken, so that AYUSH department will establish 200 Herbal gardens:

1. 200 units Herbal gardens will be established in all districts by the Ayush Department.
2. Out of 200 Herbal Gardens 50 Herbal gardens will be established in convergence with Panchwati/MGNREGA for which planting material (all medicinal plants) will be provided by the AYUSH Department.
3. In addition to this, AYUSH department will also explore the possibility of establishing other left out Herbal Gardens in Schools for the awareness of students. In this regard medicinal plants would be provided by the AYUSH department.
