- EPF registration No. is also required to be submitted within one month from the issue of this award letter, if already not given.
- This work will have to start and complete within stipulated period failing which action under the clause- 2 & 3 will be taken against you.
- Material required for execution of this work shall be arranged by you at your own level. Society will not provide the same and no escalation under 10C & 10CC will be paid.

- You will have to produce a copy of PAN and TIN to this office. In case you fail to produce the PAN & TIN, no payment of your running/final bill shall be released till the production of PAN & TIN number.

You are further requested to attend this office within fifteen days to sign the contract agreement on any working day during the office hours. In case you do not sign the agreement no payment for the work done will be released and work will also be rescind.

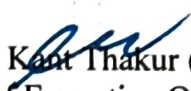
