**Subject:- Regarding implementation of orders/judgment dated
25.09.2023 of the Hon'ble High Court of HP in CWP No. 787 of
2022 and directions of Hon'ble Apex Court thereof.**

Sir,

It has come to the notice of this department that some Zila Parishads have initiated the process for regularization of Technical Assistants appointed in terms of letters No. PCH-HB(1)10/2017-T.A. Appointment-8168-248 dated 18.02.2020 and PCH-HB(1)20/2002-T.A. Una-I-40939 dated 07.07.2020, in pursuance to order/judgment passed by the Hon'ble High Court of HP on 25.09.2023 in CWP No 787 of 2022 and other connected matters.

In above context, I am to inform you that the aforesaid order/judgment passed by the learned Single Judge of the Hon'ble High Court of H.P. has been assailed by the State before the Hon'ble Apex Court and vide subsequent order dated 04.10.2024 (copy enclosed), the implementation of the directions issued by the learned Single Judge of the Hon'ble High Court has been ordered to be stayed by the Hon'ble Apex Court. Accordingly, the aforesaid order/judgment of the learned Single Judge of Hon'ble High Court has not attained finality as on date and as such, the same cannot be implemented, till final adjudication of the matter, in view of orders passed by the Hon'ble Apex Court on 04.10.2024.

In view of above, you are directed to strictly comply with the directions dated 04.10.2024 of the Hon'ble Apex Court and accordingly, the process of regularization of Technical Assistants, appointed pursuant to letters dated 18.02.2020 and 07.07.2020, if initiated by your office may immediately be stopped, till further orders, as has already been conveyed vide this office letter dated 22.02.2025 of even number (copy enclosed).
