**ORDER**

This order is being issued in compliance to the judgement dated 08.04.2026 of the Hon'ble High Court in CWP No. 4856/2026 titled as Jai Krishan Vs State of H.P. & Ors.

The brief facts of the case is as under:-

1. Sh. Jai Krishan was appointed as Group Instructor and has joined his duty on 11.06.2018 at Govt. ITI Jubbal, District Shimla. He was promoted as Principal vide this department Notification No. EDN(TE)B(2)3/2023 dated 19.08.2025. He has been posted at his present place of posting i.e. Govt. ITI Jubbal by considering his own request.
2. A transfer and posting request was received from the competent authority that he may be posted at Govt. ITI Tikkar, District Shimla. Accordingly, his request was processed and placed before the competent authority. The competent authority has considered his request and approved his posting at Govt. ITI Tikkar, District Shimla. Accordingly, transfer orders have been issued vide this department Notification TE-B/58/2026 dated 02.04.2026, but he has not joined his duties till to date and has submit that he is not feeling well.
3. These transfer orders had been challenged by himself vide filing a CWP No. 4594/2026 titled as Jai Krishan

Vs State of H.P. & ors. and has made following Relief:-

a) Issue a writ of certiorari or any other appropriate writ, order or direction quashing the impugned transfer order dated 02-04-2026 (Annexure P-2) transferring the petitioner from Government ITI, Jubbal to Government ITI, Tikkar, District Shimla.

b) In the alterative, direct the respondents to allow the petitioner to join at Government ITI Summerkot, District Shimla or Government ITI Chirgaon, District Shimla or Government ITI, Theog, District Shimla in public interest and in the interest of justice.

c) Issue a writ of mandamus directing respondents to grant TA/Joining Time and all other consequential benefits to the petitioner.

d) Grant any other relief which this Hon'ble Court deems fit and proper in the interest of justice.

His case was heard in the Hon'ble High Court and has passed following orders on 06.04.2026, which are as under :-

*“In light of the fact that the petition has been filed without impleading the person, whose transfer is under challenge, the petitioner is allowed to withdraw the petition with liberty to file afresh petition by impleading the necessary party as party respondent”*

He has filed another case having CWP No. 4856/2026 titled as Jai Krishan Vs State of H.P. & Ors. having similar grounds as

referred above. This case was heard by the Hon'ble High Court on 08.04.2026. The Hon'ble High Court has passed following order :-

*"Having heard learned counsel for the petitioner for some time, this Court is shocked that the petitioner has been able to manage his posting at Jubbal for seven years and now he is peeved by the fact that he has been transferred just to a distance of 28 kilometers.*

*State to explain as to why this favoritism is being shown to certain employees and they are not being transferred to other Districts despite the fact that they hold State Cadre posts.*

*List on 20.04.2026".*

4. To comply the orders of Hon'ble High Court the matter was placed before the competent authority. The competent authority has cancelled his transfer orders issued vide this department notification No. TE-B/58/2026 dated 02.04.2026, and has decided/ approved that Sh. Jai Krishan, Principal be transferred and posted at Govt. ITI Chhatrari, District Chamba.

In view, of this, Sh. Jai Krishan, Principal is directed to join his duty at Govt. ITI Chhatrari, District Chamba with immediate effect, failing which disciplinary action will be initiated.
