**RECRUITMENT AND PROMOTION RULES FOR THE POST OF SOCIAL EDUCATION AND BLOCK PLANNING OFFICER (NON-GAZETTED) (CLASS-111) IN THE DEPARTMENT OF RURAL DEVELOPMENT DEPARTMENT, HIMACHAL PRADESH.**

2. No. of post(s)	78 (Seventy Eight)
3. Classification	Class 111.(Non Gazetted)
4. Scale of pay	Rs.5000-160-5800-200-7000-220-8100
5. Whether "selection" post or "Non-Selection" post.	Non -Selection.
6. Age for direct recruitment.	<p>Between 18 and 45 years'</p> <p>Provided that the upper age limit for direct recruits will not be applicable to the candidates already in service of the Government including those who have been appointed on adhoc or on contract basis;</p> <p>Provided further that if a candidate appointed on adhoc basis or on contract basis had become over-age on the date he/she was appointed as such he/she shall not be eligible for any relaxation in the prescribed age- limit by virtue of his/her such adhoc or contract appointment;</p> <p>Provided further that upper age-limit is relaxable for Scheduled Castes/Scheduled Tribes/Other categories of persons to the extent permissible under the general or special order(s) of the Himachal Pradesh Government;</p> <p>Provided further that the employees of all the Public Sector Corporation and Autonomous Bodies who happened to be Government servants before absorption in Public Sector Corporation/Autonomous Bodies at the time of initial constitutions of such corporation/Autonomous Bodies shall be allowed age concession in direct recruitment as admissible to Government Servants. This concession will not, however, be admissible to such staff of the Public Sector Corporations/Autonomous Bodies who were/are subsequently appointed by such Corporations/Autonomous Bodies and who are/were finally absorbed in the service of such Corporations/Autonomous Bodies after initial constitution of the Public Sector Corporations/Autonomous Bodies.</p> <p>(1). Age limit for direct recruitment will be reckoned on the first day of the year in which the post(s) is/are advertised for inviting applications or notified to the Employment Exchange or as the case may be.</p> <p>(2). Age and experience in the case of direct recruitment, relaxable at the discretion of the Himachal Pradesh Public Service Commission in case the candidate is otherwise well qualified.</p>

Minimum education and qualifications required for direct recruit(s).</p>	<p><b>Essential Qualification(s):</b> Bachelor's Degree in Arts/Commerce/Science or its equivalent from a University/Institution recognized by the Government.</p> <p><b>Desirable Qualification(s):</b> Knowledge of customs, manners and objects of Himachal Pradesh and suitability for appointment in the peculiar conditions prevailing in the Pradesh.</p>
<p>8. Whether age and educational Qualifications prescribed for direct recruits will apply in the case of promotee(s)</p>	<p>Age: Not applicable.</p> <p>Educational Qualifications: Not applicable.</p>
<p>9. Period of probation, if any</p>	<p>"Two years" subject to such further extension for a period not exceeding one year as may be ordered by the competent authority in special circumstances and reasons to be recorded in writing.</p>
<p>10. Method of recruitment, by direct recruitment or by promotion, deputation, transfer and the percentage of post(s) to be filled in by various methods.</p>	<p>i) 90% by promotion;&amp;</p> <p>ii) 10% by direct recruitment.</p>

1. In case of recruitment by promotion, deputation, transfer, grade from which promotion/deputation/ transfer is to be made.

By promotion from amongst the Panchayat Secretaries having ten years regular service or regular combined with continuous adhoc service rendered, if any, in the grade.

Provided that for filling up the posts of Social Education & Block Planning Officer the following 10 points post based roster shall be followed:-

Roster Points No.	Feeder category
1st, 2nd, 3rd, 4th, 5th, 6th, 7th, 8th & 9th	Promotee
10 <sup>th</sup>	Direct recruitment

Note: The roster will be rotated after every 10<sup>th</sup> vacancy till the representation to all feeder categories is achieved by the given percentage. Thereafter, the vacancy is to be filled up from amongst the category which vacates the post.

1. In all cases of promotion, the continuous adhoc service rendered in the feeder post, if any, prior to regular appointment to the post shall be taken into account towards the length of service as prescribed in these Rules for promotion subject to the condition that the adhoc appointment / promotion in the feeder category had been made after following proper acceptable process of selection in accordance with the provisions of R & P Rules, provided that:-

(a) that in all cases where a junior person becomes eligible for consideration by virtue of seniority, total length of service (including the service rendered on adhoc basis, followed by regular service/appointment) in the feeder post in view of the provisions referred to above, all persons senior to him/her in the respective category / post / cadre shall be deemed to be eligible for consideration and placed above the junior persons in the field of consideration.

Provided that all incumbents to be considered for promotion shall possess the minimum qualifying service of at least 3 years' or that prescribed in the R&P Rules for the post, whichever is less;

Provided further that where a person become ineligible to be considered for promotion on account of the requirements of the proceedings proviso, the person(s) junior to him/her shall also be deemed to be ineligible for consideration for such promotions;

Explanation:- The last proviso shall not render the junior incumbent(s) ineligible for consideration for promotion if the senior ineligible person(s) happened to be Ex-Servicemen recruited under the provisions of Rule-3 of The Demobilized Armed Forces Personnel (Reservation of Services) Rules, 1972 and having been given the benefit of seniority there under or recruited under the provisions of Rule-3 of The Ex-Servicemen (Reservation of vacancies in the Himachal Pradesh Technical Services) Rules, 1985 and having been given the benefit of seniority thereunder.

(2). Similarly, in all cases of confirmation, adhoc service rendered on the feeder post, if any, prior to the regular appointment/promotion against such post shall be taken into account towards the length

	<p>of service, if the adhoc appointment/promotion had been made after proper selection and in accordance with the provision of the R&amp;P Rules.</p> <p>Provided that inter-se-seniority as a result of confirmation after taking into account, adhoc service rendered as referred to above shall remain unchanged.</p>
12. If a Departmental Promotion Committee exists, what is its composition?	As may be constituted by the Government from time to time.
13. Circumstances under which the HPPSC is to be consulted in making recruitment.	As required under the law.
14. Essential requirement for a direct recruitment	A candidate for appointment to any service or post must be a citizen of India.
15. Selection for appointment to post by direct recruitment.	Selection for appointment to the post in the case of direct recruitment shall be made on the basis of Viva Voce test if the Himachal Pradesh Public Service Commission or other recruiting authority, as the case may be, so consider necessary or expedient by a written test or practical test, the standard /syllabus etc. of which will be determined by the Commission/other recruiting authority, as the case may be.
16. Reservation	The appointment to the service shall be subject to orders regarding reservation in the service for SC/ST/ other backward classes /other categories of persons issued by the Himachal Pradesh Government from time to time.
17. Departmental Examination.	Not applicable.
18. Power to relax.	Where the State Government is of the opinion that it is necessary or expedient to do so, it may, by order for reasons to be recorded in writing and in consultation with the H.P. Public Service Commission relax any of the provisions of these rules with respect to any Class or Category of person(s) or post(s).

**"NOTIFICATION"**

In exercise of the powers conferred by proviso to Article 309 of the Constitution of India, the Governor, Himachal Pradesh, in consultation with the H.P. Public Service Commission, is pleased to make the Recruitment and Promotion Rules for the post of Social Education and Block Planning Officer Class-III (Non Gazetted), in the Rural Development Department of Himachal Pradesh as per Annexure-I appended to this Notification, namely:-


1.	Short title and commencement	1.(i) These Rules may be called the Himachal Pradesh Rural Development Department, Social Education and Block Planning Officer Class-III (Non-Gazetted) Recruitment and Promotion Rules, 2005.  (ii) These rules shall come into force from the date of publication in the Rajpatra, Himachal Pradesh.
2.	Repeal and Savings Clause	2.(i) The Himachal Pradesh Department of Rural Development Class-III Service (Recruitment, Promotion and certain condition of service) Rules, 1974 notified vide Notification number 4-123/71-E(Dev)-II dated 10 <sup>th</sup> October, 1974 and as amended from time to time are hereby repealed, to the extent these pertain to the post of Social Education and Block Planning Officer Class-III (Non-Gazetted).  (ii) Notwithstanding such repeal, any appointment made, or anything done or any action taken under the rules so repealed under rule 2(i) supra shall be deemed to have been validly made, done or taken under these Rules.
