Subject :- Preparation of draft electoral rolls of Nagar Panchayat Jhandutta and Sawarghat.

Madam/Sir,

As you are aware that the Government has notified Nagar Panchayat Jhandutta and Sawarghat vide Notification UD-A(1)-13/2024 dated 25.02.2026. The State Election Commission vide Notification No. SEC-HP-FO02(01)2021-6692 date 02.03.2026 has issued programme for delimitation of wards. As per programme delimitation of these two municipalities are scheduled to be finalized on or before 25.03.2026.

Since, the Nagar Panchayat Jhandutta and Swarghat district Bilaspur was under litigation during the preparation of electoral rolls hence, draft electoral rolls of these two Municipalities could not be generated. Therefore, following programme is issued in respect of these two Municipalities:-

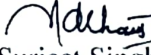
Sr. No.	Name of activity	Date of Completion of exercise
1.	Mapping of ECI Polling Station.	Within 3 days from the final publication of delimitation.
2.	Mapping of Section by Block User.	Within 1 day after mapping of ECI polling station.
3.	Verification and mapping of electors from Part-II.	Within 3 days after mapping of polling station.
4.	Print Preview copy of draft electoral rolls.	Within one day of mapping of electors.
5.	Convening of Special Meeting.	Within one day after generation of preview copy of draft electoral rolls

6.	Shifting of stage from working to draft	Within one day after convening of special meeting
7	Publication of draft electoral rolls	As per programme issued by the State Election Commission

Since both the ULBs have no house in existence at present, therefore, Sub-Divisional Officers(C)/Administrator will issue three days notice for convening a special meeting of stakeholders and the preview copies of the draft electoral rolls shall be placed before the said meeting. Instructions issued vide letter dated 01st and 23rd August, 2025 shall be adhered to strictly, wherever applicable.

As soon as draft electoral rolls are ready intimation to this effect shall be given to the State Election Commission so that the programme for preparation of electoral rolls is issued immediately.

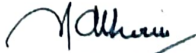
