ORDER

That Sh. Tek Chand, Sub Inspector(Panchayat), Dev. Block Tissa District Chamba approached the Hon'ble High Court by way of CWP No. 2235/2025 titled as Tek Chand vs. State of Himachal Pradesh & Others with the prayer that his Representation (Annexure P-4) may kindly be decided within time bound manner and petitioner be adjusted at station of his choice.

Accordingly, the Hon'ble High Court of H.P. disposed of the above writ petition on 13.02.2025 with following directions:

"Taking into account the entirety of facts and circumstances of this case this Court directs Respondent No.2 Director of Panchayati Raj Department, Himachal Pradesh, Shimla to decide the representation [Annexure P-4], within three weeks from today after affording a personal hearing to the petitioner. However, in the interim, this Court directs the Respondents that in pursuance to the transfer order dated 03.02.2025 [Annexure P-4] since no incumbent has been posted or has joined as Sub Inspector in Block Development Tissa, District Chamba, Himachal Pradesh, respondents are directed to permit the petitioner to work in Block Development Tissa District Chamba, H.P. notwithstanding the issuance of orders dated 3.2.2025 and relieving till the decision of the representation."

Brief facts of the case are that the petitioner Sh. Tek Chand has been transferred from Dev. Block Tissa to Dev. Block Kullu vide this office order dated 03.02.2025, in pursuance to approved proposal received from the competent

authority. But Sh. Tek Chand, SI (P) did not join in Dev. Block Kullu and has preferred the aforesaid writ petition.

Subsequently, the petitioner submitted a fresh representation before the undersigned on 18.02.2025, requesting therein that his mother is about 90 years old and require utmost care at this age hence, he may be adjusted against the post of Sub-Inspector (Panchayat) either in Dev. Block Salooni or Chamba where the said posts are lying vacant.

Upon perusal of record, it is found that the posts of sub-inspector (Panchayat) are lying vacant in Dev. Block Chamba and Salooni. Now, therefore, given special circumstances of the petitioner regarding his aged mother as well as adverse personal circumstances, and considering administrative feasibility, the petitioner/applicant is adjusted at Dev. Block Chamba, District Chamba HP against the vacant post of Sub-Inspector (Panchayat), in supersession of all previous orders.

All concerned be informed accordingly.
