### NOTIFICATION

In exercise of the powers vested in it under Article 243-ZA of the Constitution of India, Section 9 of the HP Municipal Corporation Act, 1994, Section 281 of the Himachal Pradesh Municipal Act, 1994 read with Rule 33 of the HP Municipal Corporation Rules, 2012 and Rule 35 of the H P Municipal Election Rules, 2015, the State Election Commission Himachal Pradesh hereby notifies the Election Programme for the conduct of general elections in respect of those Municipalities wherein the Government has notified the reservation and copy of the same has been received in the Commission under Rule 11 of the relevant Rules and final electoral rolls have also been published. Details of Municipalities is annexed as Annexure-I. The details of Election Programme is as under:-

1	Nomination papers shall be presented;	On <b>29.04.2026</b> , <b>30.04.2026</b> and <b>02.05.2026</b> (between 11.00 am to 3.00 pm). Nomination papers shall be filed at designated places and before the Officers appointed by the Returning Officer for the purpose.
2	The nomination papers shall be scrutinized;	<b>04<sup>th</sup> May, 2026</b> (From 10.00 am onwards)
3	A candidate may withdraw his candidature;	<b>On 06<sup>th</sup> May, 2026</b> (Before 3.00 p.m.)
4	The list of contesting candidates showing the name of symbols allotted to them shall be prepared and affixed;	On <b>06<sup>th</sup> May, 2026</b> immediately after the time of withdrawal is over.
5	The list of Polling stations shall be pasted;	On or before <b>29.04.2026</b> .
6	The Poll, if necessary, shall be held from 7.00 AM to 3.00 PM;	<b>17.05.2026</b>
7	Counting of votes, in the event of poll, shall be done;	The Counting of votes shall be taken up immediately after the close of the poll at the Municipal Headquarters in respect of Municipal Council and Nagar Panchayat.  The Counting of votes in respect of Municipal


