NOTIFICATION

The State Election Commission in exercise of the powers vested in it under Article 243K of the Constitution of India, Section 160 of the HP Panchayati Raj Act, 1994, read with Rule 12 of the HP Panchayati Raj (Election) Rules, 1994, do hereby invalidate the process undertaken for preparation of electoral rolls in respect of all the Gram Panchayats of Development mentioned hereinabove and further issues the following schedule for preparation of electoral rolls:-

1.	Publication of electoral rolls in draft	06.11.2025
2.	Period for lodging claims and objections before the Revising Authority	07.11.2025 to 17.11.2025
3.	Period for deciding claims and objections by the Revising Authority	Up to 20.11.25
4.	Period for filing appeals before the Appellate Authority	Within seven days from the order passed by the Revising Authority i.e. up to 27.11.2025
5.	Period for deciding appeals by the Appellate Authority	Up to 29.11.2025
6.	Final publication of Electoral Rolls	On or before 01st December, 2025

Further all the directions issued vide Notification No. SEC(F)1-40/2023-Vol-I- 3834 dated 01st October, 2025 shall be applicable ipso-facto to this programme.


