NOTIFICATION

Whereas the State Election Commission had issued programme for the preparation of electoral rolls vide Notification. No. SEC(F)1-40/2023-Vol-I- 3834 dated 01st October, 2025. As per programme draft electoral rolls were to be published on 06.10.2025;

And whereas it is noticed that preview copy of the electoral rolls in respect of Gram Panchayats Aura, Bajol and Holi of Development Block Bharmour District Chamba and Gram Panchayats Jhungi, Behli (Drumat), Boie and Shegal of Development Block Nihri District Mandi were not generated;

And whereas while shifting the stage from working to draft electoral rolls it is observed that the generated draft in respect of abovementioned Gram Panchayats pertains to the year 2022 instead of 2025;

And whereas the matter was considered in the Commission and the Commission is of the considered view that the directions issued by the Commission have not been adhered to in letter and spirit which has resulted into defective generation of draft electoral rolls in respect of abovementioned Gram Panchayats of District Mandi and Chamba;

Therefore, the State Election Commission in exercise of the powers vested in it under Article 243K of the Constitution of India, Section 160 of the HP Panchayati Raj Act, 1994, read with Rule 12 of the HP Panchayati Raj (Election) Rules, 1994, hereby invalidates the process undertaken for preparation of electoral rolls in respect of the Gram Panchayats mentioned hereinabove and further issues the following schedule for preparation of electoral rolls:-

1.	Generation of preview copy of draft electoral rolls	13.10.2025
2.	Convening of Special Meeting of Gram Sabha	15.10.2025

3.	Generation of Draft Electoral Rolls	16.10.2025
4.	Publication of electoral rolls in draft	17.10.2025
5.	Period for lodging claims and objections before the Revising Authority	18.10.2025 to 27.10.2025
6.	Period for deciding claims and objections by the Revising Authority	Up to 31.10.25
7.	Period for filing appeals before the Appellate Authority	Within seven days from the order passed by the Revising Authority i.e. up to 07.11.2025
8.	Period for deciding appeals by the Appellate Authority	Up to 11.11.2025
9.	Final publication of Electoral Rolls	On or before 13th November, 2025


